**GENERAL DESCRIPTION**

The SO240R conventional fire siren is used in conventional and addressed fire system, for reporting fires or emergency, audible warning. It available for outdoor using. It is connected via an extra cable on the Conventional and addressable systems.

**INSTALLATION**



SO240R Fire Siren consists of three main parts: a base part , a removable cover and small plastic cover on the screw. The base part is fixed on the base by the screws. A 1.3 Ah battery is fixed on the base part. The connection is made by the provided screw terminals. When the connection is made on the board. Front cover is placed and screwed. Small plastic cover is placed on the screw.

**WIRING**

The wiring can make by two way, first of them as shown in figure 1 and second way as shown in figure 2 Proper wire gauges should be used. The installation wires should be color-coded to limit wiring mistakes and ease system troubleshooting. Improper connections will prevent a system from responding properly in the event of a fire. Remove power from the power line before installing sirens.

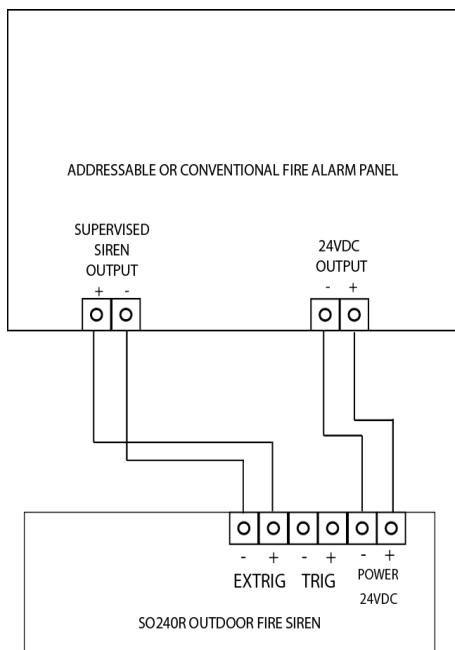

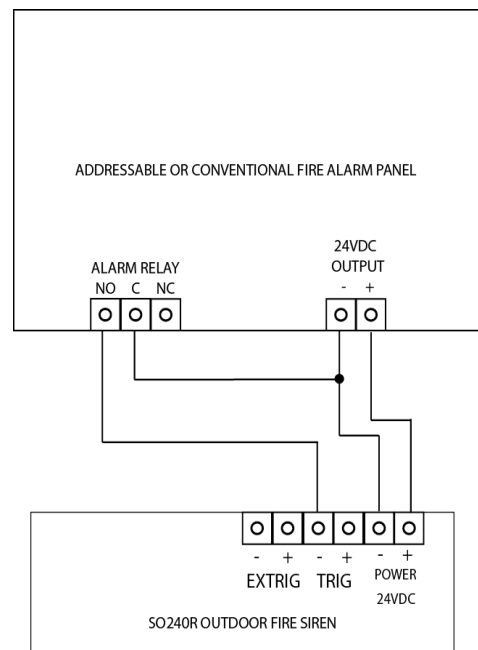
